

## **Weddings of Sarasota Member Responsibility Form 01/10**

### **Mandatory August Bridal Show:**

Fees (approx. \$250.) will be due 05/18/2010.

Payments made after 5/18 but no later than 5/30 will be accepted with a \$30. late fee.

The show will be closed to members after 05/31/10 with the exception of new members who join the group by 07/30/10 and pay the show fee with their membership.

A mandatory bridal show Grand Prize (in the form of cash) will be collected at the same time as your booth fee & is required from each member participating as an A Vendor, meaning those actively participating in the show. The fee will be determined by the Board and based on the amount of the total Grand Prize. Range \$25-\$50. No other prizes are required to be donated.

### **Optional January/February 2011 Show:**

Fees (approx. \$250.) will be due 11/16/10

Payments made after 11/16 but no later than 11/30 will be accepted with a \$30. late fee.

The show will be closed to members after 11/30/10 with no exceptions.

### **Dues 2011:**

Bonus for 2010 members - your current dues will continue through 02/28/11

2011 payments are due 03/01/11 and will be accepted through 03/16/11 with no penalty.

Payments made after 3/16 but no later than 3/31 will be accepted with a \$30 late fee.

Failure to pay dues by 3/31 will require a re-application and possible loss of full-membership if there is a waiting list for your category.

### **Dates to Note:**

Please take time now to note the above critical dates on your calendars and avoid late fee penalties or termination from the membership. This new payment schedule will allow for smoother transitions through the busy holiday period and allow adequate time for corporate accounts to requisition checks in a timely manner. No exceptions will be made.

### **Meetings:**

Meetings are consistently held the third Tuesday of every month except December. In addition, there are 4 optional evening meetings. Notice of meetings, dues etc. are sent via e-mail to all members. If communication is not received within a 30 day period - please check our website to keep up-to-date and then contact a board member to resolve the communication problem in a timely manner. Keep track of the number of meetings that you have attended to make certain that you are meeting the requirements set forth for membership.

### **Minutes:**

Review general membership minutes (especially if absent) to keep abreast of upcoming obligations, events and changes. If minutes are not received by the end of the month – it is your responsibility to contact the secretary, Alice DeLair.
